

**LOGAN TOWNSHIP ZONING BOARD OF ADJUSTMENT
REORGANIZATION MEETING MINUTES

New Business: 1 pending Application for Camping World.


Closing Comments: Uzo Ahiarakwe thanked the Zoning Board members for re-appointing him to another year and remarked it is a pleasure it was to work with them.
